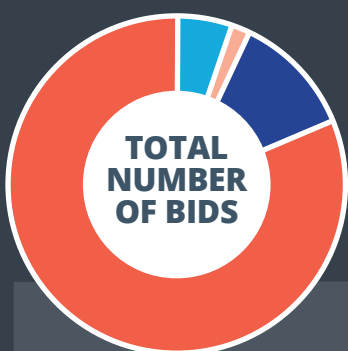




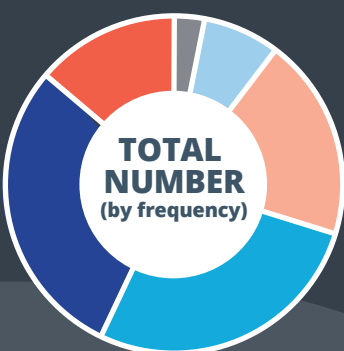

# A SNAPSHOT OF THE BID COMMUNITY

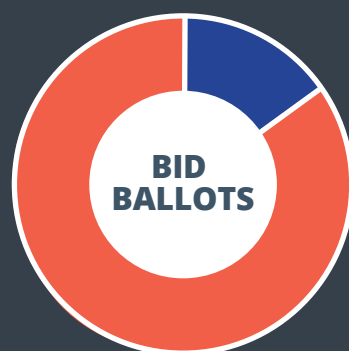

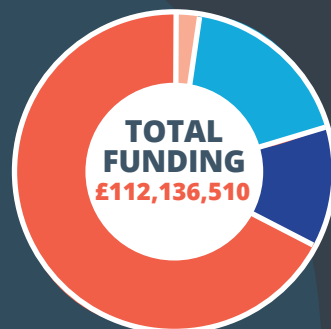
